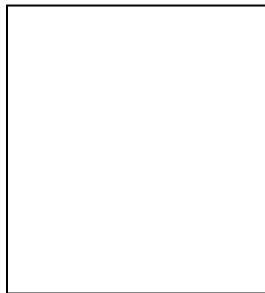

1. BOOKING, CONFIRMATION AND PAYMENT PROCEDURE

How to Book

1.1 To secure your booking, please complete and sign the True North Journeys Client Reservation Form and send it to True North Journeys with a non-refundable deposit. Any variation to deposit amounts will be advised at the time of booking.

Prices and Availability

1.2 All True North Journeys destinations are subject to availability and price variation until the final balance is paid. Prices are subject to variation if there are increases due to governmental action, additional taxes, exchange rate fluctuations, and increase in airfare components or fuel surcharges levied by transportation companies within the destinations.

1.3 Prices are expressed and payable in Australian Dollars.

Confirmation and Special Requests

1.4 A contract will exist as soon as True North Journeys confirms your arrangements in the form of a Confirmation Invoice either by mail or email within 48 hours of your deposit and Reservation Form being received.

ACKNOWLEDGEMENT AND ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION AGREEMENT

In consideration of the services provided by True North Journeys Pty Ltd, its shareholders, directors, officers, employees, agents, volunteers, participants and all other persons or entities associated with in any capacity on its behalf (collectively referred to as "TNJ", I hereby agree to release, indemnify and discharge TNJ, on behalf of myself, my heirs, assigns, personal representation and estate and for all members of my family, including minor children, as follows:

1. I acknowledge that jungle trekking, rock climbing and mountaineering entail known and unanticipated risks that could result in physical or emotional trauma, injury, paralysis, death or damage to myself, property and/or third parties. Although TNJ has taken reasonable steps to provide me with appropriate equipment and skilled guides, I understand that such risks cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: the hazards of traveling in uneven mountainous terrain and slips and falls; being struck by rock fall or other objects dislodged or thrown from above, the use of climbing ropes and equipment; the forces of nature; including lightning; weather changes; the risk of falling off the rock; mountain; river levels; bamboo river rafting; the risk of exposure to insect bites; the risk of altitude and cold including frostbite; acute mountain sickness; cerebral and pulmonary edema; my own physical condition; and the physical condition associated with this activity. Additional dangers may include the hazards of traveling in the Third World; accident or illness in remote places without access to emergency medical facilities; war, terrorism and other forces. I understand that this description of these risks is not complete and that other unanticipated risks may occur.

Furthermore, TNJ has a difficult job to perform. It seeks safety but is not infallible. It might be unaware of my or another participants' fitness or abilities. It might misjudge the weather or other environmental conditions. It may give incomplete warnings or instructions and equipment being used might malfunction. I acknowledge that engaging in this activity may require a degree of skill and knowledge different than other activities and I have responsibility as a participant. I acknowledge that TNJ has been available to more fully explain to me the nature and physical demands of this activity and the risks, hazards and dangers associated with this activity.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in the activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge and agree to indemnify and hold harmless TNJ from any and all claims, demands or causes of action which are in any way connected with my participation in this activity or my use of TNJ's equipment or facilities including any such claims which allege negligent acts or omissions of TNJ.
